## **State Fireworks Requirements**

- Public Display Permit Required: Yes, Permit required by local AHJ Fees by local AHJ, or State FM - \$125
- Commercial General Liability Insurance Coverage: \$1,000,000 per occurrence
- HazMat Transportation Insurance DOT Compliant (1.4 \$1M / 1.3 \$5M)
- State Transportation Permit Required: No
- Worker Compensation Insurance Statutory
- Import/Export License to bring products into the state: Companies must purchase from licensed companies in state of Oklahoma.
- Wholesale or Distributor License to purchase or sell products in the state: Yes
- Registration of individuals authorized to represent License holder in the state: Yes
- Permit from Local AHJ for each display: Yes Fee dependent upon location
- Permit Filing Period for Local: Depends on local jurisdiction
- Permit Filing Period for State: Yes State permit 10 days
- State Bond Required: No

## State Pyrotechnic Operator Requirements

- Minimum Age: 21
- Minimum of Documented displays: 3 under licensed pyrotechnic operator within 3 years, signed off for verification.
- Minimum Experience: 3 displays within 3 years
- Letters of Recommendation: No
- Written Test Required: Yes Test only first time, however 6 hours of continuing education training with certificate of verification of class training for renewal of license
- Minimum Passing Score: 70 percent
- New Operator License Fee: \$75.00
- Renewal Operator License Fee: \$75.00
- Renewal Period for Licensed Operator: Every 3 years

## OTHER:

- You must take a display operator class that has been approved by the Oklahoma State FM
- You must have worked under complete supervision on at least 3 displays within 3 years immediately preceding your application, and it just be verified by the supervising operator or company.
- You must contact an Oklahoma Career Tech Facility to make a testing appointment for the written examination BEFORE submitting your "Application for Outdoor Display Operator" to State FM. A list of technology centers is available at www.okhep.com under State FM tab.
- You must present valid and current Photo ID issued by US Government
- You will pay \$25 to the Career Tech Facility to take the exam, and you will take the test on computer. No resource materials allowed during exam.
- Minimum Passing Score 70%
- If you fail, you can pay an additional \$15 fee that same day to take the test again. However, if you do not retake the test on the same day, and fail again, you must wait 30 days to re-test.
- If you PASS, the Career Tech Facility will notify the State FM office, and then you submit your application, along with 2 photo ID's and \$75 fee.
- Your test results will be verified before processing your license.
